- Wedding announcements featuring pictures and additional information will be available at the following charges using the information from the Aiken Standard's wedding forms:
  - An announcement with a 1-column x 3-inch photo, will have a charge of \$50.
  - An announcement with a 2-column x 5-inch photo, will have a charge of \$100.
  - An announcement with a 3-column x 7-inch photo, will have a charge of \$150.
